

RÖNESANS REASÜRANS VE SİGORTA BROKERLİK ANONİM ŞİRKETİ WEBSITE COOKIE INFORMATION TEXT

About the Information Text

As Rönensans Reasürans Ve Sigorta Brokerlik Anonim Şirketi (“Rönensans”), we utilize certain applications such as cookies, pixels, and gifs (cookies) during your visits to our online platforms to enhance your experience. The use of these technologies is conducted in accordance with the relevant legislation, primarily the Personal Data Protection Law No. 6698 (“Law”).

The purpose of this Cookie Information Text is to inform users/members/visitors of the website (the “Site”) about the processing of personal data obtained through the use of cookies. This information explains what types of cookies are used on the Site, for what purposes, and how they can be controlled.

Purposes of Cookie Usage

Rönensans Reasürans Ve Sigorta Brokerlik Anonim Şirketi uses cookies for various purposes on the Site, and personal data is processed through these cookies. The main purposes are as follows:

To perform essential functions necessary for the operation of the Site: For instance, facilitating functions that allow logged-in members to navigate through different pages without having to re-enter their passwords.

To analyze the Site and improve its performance: Applications that integrate the different servers the Site operates on, determine the number of visitors to the Site, and adjust performance settings accordingly, as well as facilitate visitors in finding what they are looking for.

In accordance with Articles 5 and 8 of the Law, personal data can be processed in line with the above purposes with the consent of the data subject in necessary cases specified by the relevant legislation and without obtaining consent in other cases. As Rönensans Reasürans Ve Sigorta Brokerlik Anonim Şirketi, the personal data within the scope of this information text may be shared with suppliers, legally authorized public institutions, and third parties only to the extent necessary for the fulfillment of the aforementioned purposes and in compliance with the law. The recipient of the data may store this personal data on servers located worldwide.

Cookies Used on the Site

The different types of cookies used on the Site are as follows. Both first-party cookies (set by the visited Site) and third-party cookies (set by servers outside the visited site) are used on the Site.

Mandatory Cookies

The use of certain cookies is essential for the proper functioning of the Site. Authentication cookies activated when logged into the Site ensure the continuity of the session while navigating from one page to another.

Performance and Analysis Cookies

These cookies enable the analysis of Site usage and performance, thereby improving the services offered. They identify which pages visitors view most frequently, whether the Site is functioning as intended, and detect potential issues.

Cookies	Explanations
ASP.NET_SessionId	This cookie is used only on websites with a login field. It is necessary to identify requests coming from the same browser within a limited session duration while navigating the website. (It expires when you close your browser.)
_ga	It is used by Google Analytics to assess the purpose of user visits and generates reports related to website activity for website administrators, aiming to improve the customer experience.
_gat	This cookie is used by Google Analytics to evaluate the purpose of user visits and generates reports related to website activity for website administrators, aiming to improve the customer experience.
_gid	It is associated with Google Universal Analytics. This is a new cookie, and no information has been provided by Google. It appears to record and update a unique value for each page visited.
_ym_d	Determines whether a user has ad blockers.
_ym_isad	Records the date of the user's first site session.
_ym_metrika_enabled, _ym_mp2_substs_	These cookies are used to measure and analyze traffic on this website. The cookies utilize the Yandex Metrika script belonging to Yandex..
_ym_uid	Ensures that the Session Replay works correctly.
_ym_visorc_20637298	These cookies are used to measure and analyze traffic on this website. The cookies utilize the Yandex Metrika script belonging to Yandex.
metrika_enabled	This cookie is used to track visitors across multiple websites to serve ads that are relevant to the visitor's preferences.

Rights of Data Subjects

According to Article 11 of the Law, data subjects have the right to:

Learn whether their personal data is being processed,
Request information regarding their personal data if it has been processed,

Understand the purpose of processing personal data and whether it is used in accordance with its purpose,
Know the third parties to whom personal data has been transferred, either domestically or internationally,
Request the correction of personal data if it is incomplete or inaccurately processed and request that the operation performed in this context is notified to the third parties to whom personal data has been transferred,

Request the deletion or destruction of personal data when the reasons necessitating its processing have ceased to exist, despite having been processed in accordance with the Law and other relevant legal provisions, and request that the operation performed in this context is notified to the third parties to whom personal data has been transferred,

Object to the emergence of a result against the person by solely analyzing the processed data through automated systems,

Request compensation for damages suffered due to unlawful processing of personal data.

Requests regarding these rights will be evaluated and concluded as soon as possible and no later than 30 (thirty) days when submitted to Rönensans Reasürans Ve Sigorta Brokerlik Anonim Şirketi using the methods indicated in the "Data Subject Application Form" document found at (<https://www.ronesansbroker.com/>). While no fee is generally charged for these requests, Rönensans Reasürans Ve Sigorta Brokerlik Anonim Şirketi reserves the right to charge a fee according to the tariff determined by the KVK Board.

As Rönensans Reasürans Ve Sigorta Brokerlik Anonim Şirketi, we may refrain from using cookies on the Site, change their types or functions, or add new cookies to the Site.

Rönensans Reasürans Ve Sigorta Brokerlik Anonim Şirketi may change the provisions of this clarification text at any time. Any changes made to the updated clarification text will take effect upon publication on the site. The date of the last update is at the beginning of the text.

The Data Subject acknowledges that they may not fully benefit from the Site's operation if they make a request that results in their personal data not being used by Rönensans Reasürans Ve Sigorta Brokerlik Anonim Şirketi and declares that all responsibilities arising in this context will belong to them.

RÖNESANS REASÜRANS VE SİGORTA BROKERLİK ANONİM ŞİRKETİ COOKIE POLICY

As Rönesans Reasürans Ve Sigorta Brokerlik Anonim Şirketi (“Rönesans”), we process personal data of visitors (“visitor”) to our website (“https://www.ronesansbroker.com/”) in accordance with the Law No. 6698 on the Protection of Personal Data (“Law”) and we protect their privacy. This Website Privacy and Cookie Policy (“Policy”) establishes the processing of personal data of visitors, cookie policy, and privacy principles of the website.

Cookies are small text files that store small pieces of information. Cookies are stored on your device or network server by websites you visit through browsers. When the website loads in your browser, the cookies are saved on your device. Cookies ensure that the website works properly, makes it more secure, and provides a better user experience. Session and local storage areas are also used for the same purpose as cookies. Our website does not contain cookies; instead, session and local storage areas are in operation.

Cookies are used to ensure that our website is utilized most effectively by visitors. If cookies are not preferred, they can be deleted or blocked through browser settings. However, this may adversely affect the performance of our website. It is assumed that the visitor accepts the use of cookies on this site unless they change their cookie settings in the browser.

1. Purpose of Processing Personal Data

Personal data obtained as a result of your visit to our website is processed by Rönesans in accordance with Articles 5 and 6 of the Law for the following purposes:

To carry out the necessary activities for conducting the commercial activities of Rönesans and to perform related business processes,

To conduct necessary studies to enable relevant persons to benefit from the products and services offered by Rönesans, and to execute related business processes,

To customize and promote the products and services offered by Rönesans based on the preferences, usage habits, and needs of the relevant persons.

2. Parties to Whom Personal Data is Transferred and the Purpose of Transfer

Your personal data obtained as a result of visiting our website may be transferred in line with the purposes of processing personal data to real persons and private law entities, shareholders/business partners, suppliers, legally authorized public institutions, and contracted service providers, within the scope of the personal data processing conditions and purposes specified in Articles 8 and 9 of the Law.

3. Method of Collecting Personal Data

Cookies are small text files that are stored on your device or network server by websites visited through browsers. When our website is visited, cookies are applied not only to our website but also to domains such as google.com, facebook.com, twitter.com, instagram.com, linkedin.com, and youtube.com with the visitor's permission.

4. Purpose of Using Cookies

Our website uses first-party and third-party cookies. First-party cookies are mainly necessary for the website to function correctly and do not retain your personal data. Third-party cookies are used to improve the performance, interaction, security, and advertising of our website, ultimately providing a better service. They help accelerate user experience and future interactions with our website. In this context, cookies serve the following purposes:

Statistics: These cookies store information such as the number of visitors to the website, the number of unique visitors, which pages of the website are visited, the source of the visit, etc. This data helps analyze how well the website performs.

Marketing: Our website runs advertisements. These cookies are used to personalize the ads we show you, making them relevant to you. They also help us track the effectiveness of these advertising campaigns. The information stored in these cookies can also be used by third-party advertising providers to show you ads on other websites in your browser.

Functional: These are cookies that help with some non-essential functions on our website. These functions may include embedding content such as videos or sharing content on social media platforms.

Preferences: These cookies help us save your settings and define your browsing preferences, such as language preferences, so you have a better and more efficient experience during your future visits to the website.

The types of cookies used on our website are shown in the table below.

<i>Session Cookies</i>	Session Cookies are temporary cookies used during visitors' visits to our website, which are deleted after the browser is closed. Their purpose is to ensure that the website functions properly during your visit.

<i>Persistent Cookies</i>	Persistent Cookies are types of cookies used to enhance the functionality of the website and provide visitors with faster and better service. These cookies are used to remember your preferences and are stored on your device through browsers.
<i>Technical Cookies</i>	Technical Cookies ensure the operation of the website and identify non-functioning pages and areas on the website.
<i>Authentication Cookies</i>	If visitors log into the website using their passwords, they are recognized as site users on each page they visit, preventing them from having to re-enter their password on every page.
<i>Flash Cookies</i>	These are types of cookies used to activate visual or audio content available on the website.
<i>Customization Cookies</i>	Cookies are used to remember users' preferences, such as language, even when visiting different pages of the website.
<i>Analytical Cookies</i>	These cookies track analytical results, such as the number of visitors to the website, the pages viewed, visit times, and scroll movements across pages.

Main Purposes of Using Cookies on Our Website

To improve the services offered to you by enhancing the functionality and performance of the website,
To enhance the website and provide new features through the website, personalizing the offered features according to your preferences,

To ensure the legal and commercial security of both you and Öz Doğan Hırdavat.

1. Controlling Cookie Preferences

Different browsers provide various methods for blocking and deleting cookies used by websites. To block/delete cookies, browser settings should be changed. 2. Rights of Data Subjects

Depending on the nature of the request, applications will be concluded free of charge as soon as possible and within a maximum of thirty days; however, if the process requires an additional cost, a fee may be charged according to the tariff determined by the Personal Data Protection Authority.

3. Effectiveness of the Policy

This Policy takes effect on the date it is published. If the entire Policy or specific articles are renewed, the effective date of the Policy will be revised.
