## Website Cookie Disclosure Statement

### About the Disclosure Statement

As Rönensans Reasürans and Insurance Brokerage Joint Stock Company ("Rönensans"), we use certain technologies such as cookies, pixels, and GIFs (collectively referred to as "cookies") during your visits to our online platforms to enhance your experience. The use of these technologies is carried out in compliance with the relevant legislation, primarily the Personal Data Protection Law No. 6698 ("Law").

The purpose of this Cookie Disclosure Statement is to provide information regarding the processing of personal data obtained through the use of cookies by users/members/visitors of the website (<https://www.ronesansbroker.com/>) ("Site") during its publication. This disclosure explains which types of cookies are used on the Site, for what purposes, and how you can control these cookies.

### Purposes for Using Cookies

Rönensans Reasürans and Insurance Brokerage Joint Stock Company uses cookies on the Site for various purposes and processes personal data through these cookies. The main purposes are as follows:

- To perform essential functions necessary for the operation of the Site: These include functions that facilitate user experience, such as ensuring members who have logged in do not have to re-enter their passwords when navigating between different pages of the Site.
- To analyze the Site and improve its performance: This involves tasks such as integrating the different servers on which the Site operates, determining the number of visitors to the Site, adjusting performance settings accordingly, and implementing features that make it easier for visitors to find what they are looking for.

In accordance with Articles 5 and 8 of the Law and under relevant legislation, personal data may be processed for the purposes stated above, either based on consent when necessary or without consent in cases where exceptions apply. As Rönensans Reasürans and Insurance Brokerage Joint Stock Company, the personal data outlined in this disclosure may be shared with suppliers, legally authorized public institutions, and individuals in compliance with the law, limited to the purposes mentioned above. The recipient of the data may store this personal data on servers located anywhere in the world.

### Cookies Used on the Site

Different types of cookies are used on the Site. Both first-party cookies (placed by the Site being visited) and third-party cookies (placed by servers other than the Site being visited) are used.

### Essential Cookies

The use of certain cookies is mandatory for the Site to function properly. For example, authentication cookies that are activated when you log into the Site ensure that the session remains active as you move from one page to another.

### Performance and Analysis Cookies

These cookies help analyze Site usage and performance, improving the services offered. They detect which pages are most viewed by visitors, whether the Site functions as expected, and identify potential problems.

<b>Cookies</b>	<b>Details</b>
ASP.NET_SessionId	This cookie is only used on websites in a login area. It is necessary to identify requests from the same browser during a limited session time while browsing the website. (It expires when you close your browser.)
_ga	It is used by Google Analytics to assess the purpose of the user's visit and creates reports on website activity for site administrators, aiming to improve the customer experience.
_gat	This cookie is used by Google Analytics to assess the purpose of the user's visit, create reports on website activity for site administrators, and aims to improve the customer experience.
_gid	It is associated with Google Universal Analytics. This is a new cookie, and no information has been provided by Google. As observed, it records and updates a unique value for each page visited.
_ym_d	Determines whether a user has ad blockers.
_ym_isad	Records the date of a user's first session on the site.
_ym_metrika_enabled, _ym_mp2_substs_	These cookies are used to measure and analyze traffic on this website. The cookies use the Yandex Metrika script, which belongs to Yandex.
_ym_uid	Ensures that Session Replay functions properly.
_ym_visorc_20637298	These cookies are used to measure and analyze traffic on this website. The cookies use the Yandex Metrika script, which belongs to Yandex.
metrika_enabled	This cookie is used to track visitors across multiple websites to deliver ads tailored to the visitor's preferences.

### Data Subject Rights

In accordance with Article 11 of the Law, data subjects have the right to:

- Learn whether personal data is being processed,
- Request information if personal data has been processed,
- Learn the purpose of processing personal data and whether it is being used in accordance with the intended purpose,
- Know the third parties to whom personal data has been transferred, either domestically or abroad,
- Request correction of personal data if it has been processed incompletely or inaccurately, and request that the correction be communicated to the third parties to whom the personal data was transferred,
- Request the deletion or destruction of personal data if the reasons for processing no longer exist, even if the data has been processed in accordance with the law and other relevant regulations, and request that this be communicated to third parties to whom the data has been transferred,
- Object to any negative outcome arising from the exclusive analysis of processed data by automated systems,
- Request compensation if they suffer damage due to unlawful processing of personal data.

Requests related to these rights can be submitted to Rönensans Reasürans and Insurance Brokerage Joint Stock Company through the methods specified in the "Data Subject Application Form" available at (<https://www.ronesansbroker.com/>). Applications will be evaluated and finalized as soon as possible, but no later than 30 (thirty) days. While it is generally essential that no fees are charged for these requests, Rönensans Reasürans and Insurance Brokerage Joint Stock Company reserves the right to charge a fee based on the tariff set by the Personal Data Protection Board.

Rönensans Reasürans and Insurance Brokerage Joint Stock Company may cease using cookies on the Site, change their types or functions, or add new cookies to the Site.

Rönensans Reasürans and Insurance Brokerage Joint Stock Company reserves the right to change the provisions of this disclosure statement at any time. Any changes to the updated disclosure statement will take effect upon publication on the website. The last update date is stated at the top of the statement.

The Data Subject acknowledges that if they make a request that results in the inability of Rönensans Reasürans and Insurance Brokerage Joint Stock Company to use any of their personal data, they may not be able to fully benefit from the operation of the Site, and they accept that any responsibility arising from this will lie with them.

## RÖNESANS REASÜRANS VE SİGORTA BROKERLİK ANONİM ŞİRKETİ COOKIE POLICY

("Rönesans") processes and protects the personal data of visitors ("visitor") to the website ("<https://www.ronesansbroker.com/>") in accordance with the Personal Data Protection Law No. 6698 ("Law"). This Website Privacy and Cookie Policy ("Policy") outlines the processing of visitors' personal data, cookie policies, and website privacy principles.

Cookies are small text files that store small amounts of information. Cookies are stored on your device or network server through browsers by the websites you visit. When the website is loaded in your browser, the cookies are stored on your device. Cookies ensure the website functions properly, is made more secure, and provides a better user experience. Session and local storage areas are also used for the same purposes as cookies. Our website does not use cookies, but session and local storage areas are operational.

To ensure that visitors can benefit from our website in the most efficient way, cookies are used. If cookies are not preferred, they can be deleted or blocked from browser settings. However, this may negatively affect the performance of our website. Unless the visitor changes the cookie settings in their browser, it is assumed they accept the use of cookies on this site.

### 1. Purpose of Processing Personal Data

Your personal data obtained due to your visit to our website is processed by Rönesans in accordance with Articles 5 and 6 of the Law for the following purposes:

- Conducting necessary activities for the execution of the commercial activities carried out by Rönesans and related business processes,
- Conducting necessary activities to ensure the relevant persons benefit from the products and services offered by Rönesans and related business processes,
- Customizing and promoting the products and services offered by Rönesans according to the likes, usage habits, and needs of the relevant persons.

### 2. Parties to Whom Personal Data is Transferred and the Purpose of Transfer

Your personal data obtained due to your visit to our website may be transferred to natural persons and private legal entities, our shareholders/business partners, suppliers, legally authorized public institutions, and organizations with which we have contractual service collaborations, in accordance with the conditions and purposes for personal data processing specified in Articles 8 and 9 of the Law.

### 3. Method of Collecting Personal Data

Cookies are small text files stored on the device or network server through browsers by the websites visited. When our website is visited, cookies are applied not only to our website but also, with the visitor's permission, to domains such as google.com, facebook.com, twitter.com, instagram.com, linkedin.com, and youtube.com.

### 4. Purpose of Using Cookies

Our website uses both first-party and third-party cookies. First-party cookies are mostly necessary for the website to function properly and do not store personal data. Third-party cookies are used to improve the performance, interaction, security, and advertising of our website, ultimately providing better service. These cookies also help speed up future interactions with our website. In this context, cookies are used for the following purposes:

**Statistics:** These cookies store information such as the number of visitors to the website, the number of unique visitors, which pages of the website were visited, and the source of the visit. This data helps us analyze and improve the website's performance.

**Marketing:** Our website serves advertisements. These cookies are used to personalize the ads we show you, making them more meaningful to you. They also help us track the effectiveness of these ad campaigns. The information stored in these cookies may also be used by third-party ad providers to show you ads on other websites in your browser.

**Functional:** These are cookies that help with some non-essential functions on our website. These functions include embedding content such as videos or sharing website content on social media platforms.

**Preferences:** These cookies help us save your settings and browsing preferences, such as language preferences, so that you have a better and more efficient experience on future visits to the website.

The types of cookies technically used on our website are shown in the table below.

<i>Session Cookies</i>	<b>Session Cookies</b> are temporary cookies used during visitors' visits to our website, which are deleted after the browser is closed. Their purpose is to ensure that the website functions properly during your visit.
<i>Persistent Cookies</i>	<b>Persistent Cookies</b> are types of cookies used to enhance the functionality of the website and provide visitors with faster and better service. These cookies are used to remember your preferences and are stored on your device through browsers.
<i>Technical Cookies</i>	<b>Technical Cookies</b> ensure the operation of the website and identify non-functioning pages and areas on the website.
<i>Authentication Cookies</i>	If visitors log into the website using their passwords, they are recognized as site users on each page they visit, preventing them from having to re-enter their password on every page.
<i>Flash Cookies</i>	These are types of cookies used to activate visual or audio content available on the website.
<i>Customization Cookies</i>	Cookies are used to remember users' preferences, such as language, even when visiting different pages of the website.
<i>Analytical Cookies</i>	These cookies track analytical results, such as the number of visitors to the website, the pages viewed, visit times, and scroll movements across pages.

- To improve the website, offer new features through the website, and personalize the features offered based on your preferences,

#### 1. Controlling Cookie Preferences

#### 2. Rights of Data Subjects

Requests related to the rights of data subjects, as regulated in Article 11 of the Law on the Protection of Personal Data, can be submitted to Ronesans by filling out the Personal Data Application Form, which can be accessed at <https://www.ronesansbroker.com/>. Depending on the nature of the request, applications will be finalized as soon as possible, but no later than thirty days, and without charge. However, if the process incurs any additional costs, a fee may be charged according to the tariff set by the Personal Data Protection Board.

#### 3. Enforcement of the Policy

This Policy comes into force on the date it is published. In the event of an update to the entire Policy or certain articles, the enforcement date of the Policy will be revised.
